

FIA Esports European Hill Climb Cup 2026

GTElite Wheel Plate Edition Prize Contest

Official Rules

1. **Promoter:** The Promoter of the FIA Esports European Hill Climb Cup 2026 GTElite Wheel Plate Edition Prize Contest (the "Contest") is the **Fédération Internationale de l'Automobile, 8, Place de la Concorde, 75008 Paris, France, SIRET 78435412800018.**

2. **Eligibility:** This Contest is open, where lawful, only to natural persons with legal capacity who are eighteen (18) years of age or older at the time of entry, who register as a Competitor (as defined in FIA regulations) for the FIA Esports European Hill Climb Cup 2026 Online Qualification (the "Cup Qualification") and whose driver records at least one valid time on the leaderboard of the Cup Qualification. The eligibility requirements applicable to Competitors under the FIA regulations apply and must be satisfied. Employees of the Promoter and Next Level Racing, and their immediate family and household members, are not eligible to participate.

By participating in the Contest, entrants ("Entrants") unconditionally accept and agree to comply with and abide by these Official Rules and the decisions of the Promoter, including the interpretation of these Official Rules, administration of the Contest, selection of the Winner, and the Promoter's exercise of discretion, which will be final, non-appealable, and binding in all respects.

3. **Contest Period:** The Contest will open at 12:00 a.m. GMT on 20 August 2026 and close at 11:59 p.m. GMT on 7 September 2026 (the "Contest Period").
4. **No purchase necessary.** No purchase or payment of any kind is necessary to enter or win. Internet access is required to enter. Participation in the Contest is entirely voluntary and is not required in order to register for or participate in Cup Qualification. Participation in the Contest will not affect an Entrant's eligibility for, participation in, or results of the Cup Qualification.

5. **To enter:** During the Contest Period, Entrants must:

- (i) Visit <https://esportseuropeanhillclimb.fia.com/> and register to the Cup Qualification by completing the entry form, which will require Entrants to provide their personal details.
- (ii) Answer the question made available as part of the Contest entry process (the "Contest Question").

To be eligible for selection as a Winner, Entrants must answer the Contest Question and their driver must record at least one valid time on the leaderboard of the Cup Qualification.

6. **Entrants may enter once per person.** Each Entrant is limited to one (1) entry. Multiple entries from the same individual may result in disqualification of all entries submitted by that individual.

7. The Promoter accepts no responsibility for entries that are incomplete, late, lost, misdirected, corrupted, delayed or otherwise not received for any reason, including as a result of any network, computer hardware, software, website, server or platform failure, outage or disruption. The Promoter reserves the right to disqualify any Entrant it reasonably believes is attempting to fraudulently enter, cheat, or compromise the system either by technical means (e.g., scripting, automation or use of bots to submit entries), or manual means (e.g., creation of multiple entries or use of multiple email addresses), or by manipulation, forgery or duplication.
8. **Prize:** One (1) GTElite Wheel Plate Edition, provided by FIA Esports' partner Next Level Racing Simulations PTY LTD ("Next Level Racing") is available to be won (the "Prize"). The Prize has an approximate retail value of EUR 699. The Prize will be delivered to the Winner by Next Level Racing at no cost to the Winner, with all shipping, transportation, customs duties, import taxes and other delivery-related charges being borne by Next Level Racing.

The Prize is personal to the Winner and is non-transferable, non-exchangeable and non-refundable. No cash alternative, redemption or substitution shall be offered, except at the Promoter's sole discretion. The Winner shall have no right to receive any cash payment in lieu of all or any part of the Prize. There are no shared prize pools between countries. Any difference between the stated approximate retail value of the Prize and its actual value shall not be awarded to the Winner.

9. **Winner selection:** This is a skill-based contest. The Winner will be the Entrant who submits the best answer to the Contest Question, as determined by the Promoter on the basis of originality, creativity and relevance to the Contest Question, subject to verification of eligibility and acceptance of the Prize. The Promoter's decision will be final and binding, subject to applicable law, and no correspondence will be entered into in relation to the outcome of the Contest, except with the Winner.

The potential Winner will be subject to verification of eligibility and compliance with these Official Rules before being confirmed as a Winner. If a potential Winner is found to be ineligible, fails to comply with these Official Rules, declines the Prize or is otherwise unable to accept the Prize, the next highest-ranked eligible Entrant will be selected, and will also be subject to verification.

10. **Acceptance of the Prize:** The potential Winner will be notified via the email address provided with their entry within thirty (30) days following the later of (i) the end of the Contest Period and (ii) verification that the Entrants have satisfied the eligibility requirements. The potential Winner must confirm acceptance of the Prize within the timeframe specified by the Promoter. The Promoter may require the potential Winner to provide proof of identity, age, residence and/or eligibility.

If a potential Winner (i) fails to respond or accept the Prize within the specified timeframe, (ii) is found to be ineligible or not in compliance with these Official Rules, (iii) declines the Prize, or (iv) cannot be contacted after reasonable efforts have been made by the Promoter, including where any notification is returned as undeliverable, the Prize shall be forfeited and the Promoter may, at its sole discretion, award the Prize to the next highest-ranked eligible Entrant.

[notice](#), which govern the collection and processing of participants' personal data in connection with the FIA Esports competition.

For the purposes of administering this Contest, validating entries, selecting and contacting the Winner, verifying eligibility and awarding the Prize, the Promoter may process personal data already collected in connection with the Entrant's Cup Qualification registration.

For the sole purpose of arranging and delivering the Prize, the Promoter will share the Winner's name, delivery address and, where necessary, contact details with Next Level Racing, the supplier of the Prize.

Personal data processed in connection with this Contest will be retained only for as long as necessary to administer the Contest, award the Prize and comply with applicable legal or regulatory obligations.

The Promoter may disclose information relating to the Winner to competent regulatory, judicial or administrative authorities where required by applicable law.

- 12. Liability:** To the fullest extent permitted by applicable law, the Promoter shall not be liable for any loss, damage or injury arising out of or in connection with participation in the Contest or the acceptance, use or enjoyment of the Prize, except where such loss, damage or injury is caused by the Promoter's gross negligence, wilful misconduct, fraud or any liability that cannot lawfully be excluded or limited under applicable law.

The Prize is supplied by Next Level Racing. To the fullest extent permitted by applicable law, the Promoter makes no representations or warranties regarding the Prize and shall not be responsible for any defect, malfunction or deficiency in the Prize attributable to its manufacture or supply.

The Promoter will not be liable for any failure to comply with, or delay in performing, its obligations under these Official Rules where such failure or delay is caused by circumstances beyond the reasonable control of the Promoter, including any failure, outage or disruption of the Contest website, servers or related systems.

- 13. Relationship with the Cup Qualification:** Nothing in these Official Rules shall amend, modify, replace or otherwise affect the terms and conditions applicable to participation in the Cup Qualification. These Official Rules shall apply solely in relation to the Contest and the Prize, and the terms and conditions governing the Cup Qualification shall continue to apply to participation in the Cup Qualification.
- 14.** If individual provisions of these Official Rules are or become invalid, the validity of the remaining Official Rules shall remain unaffected.
- 15. Governing Law and Disputes:** These Official Rules shall be governed by and construed in accordance with French law, without prejudice to any mandatory rights or protections that may be afforded to Entrants under the laws of their country of residence and which cannot be excluded or limited by agreement. In the event of any question regarding the interpretation or application of these Official Rules, the Promoter's decision shall be final, subject to applicable law. The Promoter and Entrants shall endeavour to resolve amicably any dispute arising out of or in connection with these Official Rules. Failing an amicable

resolution, any dispute shall be submitted to the competent courts of France in accordance with the applicable rules governing jurisdiction.
